## **How We Use Your Personal Data** (Legal Basis for Processing)

**Tata Elxsi Limited** takes your privacy very seriously and will never disclose, share or sell your data without your consent; unless required to do so by law. We only retain your data for as long as is necessary

and for the purpose(s) specified in this notice. The purposes and reasons for processing your personal data are detailed below: -

- We process your personal data in the performance of a contract as your employer to ensure that we meet our legal employer obligations and employment law requirements.
- We process your personal data as part of our legal obligation for business accounting, payroll and tax purposes.
- We process special category data about you as part of our employment obligations to ensure that any disabilities, health conditions and religious requirements are known.
- We process your personal data under legitimate interests to conduct background checks as part of our due diligence measures.

## **Your Rights**

You have the right to access any personal information that **Tata Elxsi Limited** processes about you and to request information about: -

- What personal data do we hold about you
- The purposes of the processing
- The categories of personal data concerned

- How long do we intend to store your personal data
- If we did not collect the data directly from you, information about the source

If you believe that we hold any incomplete or inaccurate data about you, you have the right to ask us to correct and/or complete the information, and we will strive to do so as quickly as possible; unless there is a valid reason for not doing so, which will be notified to you.

You also have the right to request the erasure of your personal data or to restrict processing (*where applicable*) in accordance with the data protection laws and to object to any direct marketing from us. Where applicable, you have the right to data portability of your information and the right to be informed about any automated decision-making we may use.

If you request to exercise any of the above rights, we may ask you to verify your identity before acting on the request. This is to ensure that your data is protected and kept secure.

#### **Sharing and Disclosing Your Personal Information**

We disclose your personal information only for the purposes specified in this notice or where there is a legal requirement.

We will only request and process the minimum necessary data for the specified purpose and ensure that the required protective measures and security is in place for all special category data.
