This notice may be reposted pursuant to USCIS Guidelines (Efren Hernandez Letter issued October 23, 2003), confirming that an amended I-129 is not necessary where an H-1B employee is being moved to a location where a Labor Condition Application is in place. Where a proposed worksite falls within the same "area of intended employment," as defined at 20 CFR § 656.3, as the previous worksite, a new Labor Condition Application is not required. The employer needs only re-post the Notice of Filing at the new worksite.
